Buried Wilson Family Cemetery Monon White Co IN. Served as one of 3 original Associate Judges for White Co IN. Presided over the First trial held in White Co IN. (A humorous case of malicious mischief) Grandson of Mary Wilson b.1715 d.June 1810. Son of James Wilson b.11/2/1731 d.2/5/1826 and 1st wife unk. 2nd wife Rebecah Jones b1752 d.4/22/1826. James and Rebecah donated the Buildings and Ground for the Sanner Church, Somerset Co PA. A Joint Presbyterian and German Reformed (Luthern) effort at it's inception. Will for James recorded in Knox Co OH Jackson Twsp.

Jane King, b. 9/4/1766; m. Thomas Wilson on 2/24/1789; d. 10/8/1834.

Was the First death recorded in Monon Twsp. Dau of Christopher King b.1733 d.1811 and Rachal Leech b.3/11/1740 d.11/7/1826. Jane was Sister to Perry Co Ohio State Representative Thomas King. Jane Buried Wilson Family Cemetery Monon White Co IN

Thomas Wilson and Jane King; jointly donated the ground, with their neighbor Robert Pherson and his spouse Elizabeth MaGruder, the land for the Unity Presbyterian Church in Perry Co OH. Pastor Thomas Moore.

Notes for CHRISTIAN MAY:

1880 PA Census, Somerset, PA shows Christian widowed by 1900. No record of him ever being married.

He was living with his sister Elizabeth in 1880 in Lower Turkeyfoot Township, Somerset Co., PA. A niece, Emma Younkin, age 13 also shows on this Census. The name Christopher appears on this census, not Christian.

John died of organic heart disease at the age of 61y, 10m, 4d.

He served as a substitute for Joseph Tressler of Somerset Co.. PA for one year in the Civil War. He was in the 58th Regiment, Pennsylvania Infantry, Company C. Roll date October 31, 1864 at Chambersburg, Pa.

Mustered out November 9, 1865. He was discharged at Covington, VA. Signed his name with an "X" when enrolling. (Source History of PA Volunteers 1861-1865). Union Army. Age 17 at enlistment. John was 5'6" tall, blue eyes, light hair, fair complexion. John's pension was \$12 per month. It was alleged that while on duty at Bet Chaplain Farm & Whilthouse Ld., VA on or about March 18 or 20, 1865, he was disabled by sprained ankle (contracted disease of feet). This info from his Pension Records. Have copies of his pension records. These were the following witnesses for Amanda to receive John's Civil War Pension: John Williams, Ann Williams, Charles S. Beal, Henry Gray

After the Civil War, John worked at the Grading Railroad in 1870, and then was a coal miner from 1870 to 1882. A Charles S. Beal and a Henry Gray signed affidavits after John's death attesting to his bad feet. John was able to only work 1/2 of what an able-bodied man could.

John bought 16 1/4 acres of land in Lower Turkeyfoot Twp, Somerset Cty. PA from a Thomas Lichty, Frank Lichty and Ezra Lichty for \$240.00 on October 19, 1898. Have copy of "Indenture" papers. Recorded in Deed Book Vol 123, Pg. 245.

Have copy of death certificate. His death certificate has Amanda May as his mother (a mistake, Amanda May was his wife.) His death certificate was signed by Jesse James Rittenour, his son-in-law and my grandfather, not well educated, possibly didn't understand form. Jesse Rittenour was living with his wife, Eliza Jane Crosby and Amanda May Crosby in 1910.

There is a marker on John's grave "Co. G, 58 PA and a star shaped marker that reads GAR 1861-1865.

HISTORY OF THE MEESE FAMILY

The earliest history, which we have been able to obtain of the Meese Family, is that they came from Holland and were of German descent.

Baltzer or Balthester Meese was born about 1758. He fought under George Washington in the Revolutionary War. We have it that he carried the Flag in the Battle of Bunker Hill, at the age of 17 years, and was also in the Battle with the Hessians.

HIS MILITARY RECORDS – Baltzer Meese rendered five years of faithful service to his country during the Revolutionary War. We find his name on the roll of Captain Lewis Farmer's Company of riflemen June 1st, 1776. Commanded by Col. Samuel Miles after his name in brackets is printed "See Second Penna." For the authority of this statement see page 420 Vol. 2nd Fifth Series Pennsylvania Archives. A reference to page 417 same volume of same series says that he enlisted in second Pennsylvania Regiment April 1776 and further that the Regiment participated in the battle on Long Island on August 27, 1776.

On page 882 same volume, same series it records that he enlisted in 1776, was discharged in 1781 and resided in Somerset County in 1835, age 74. A reference to page 120, volume 4, fifth series Pennsylvania Archives shows that he received the depreciation pay, which was some time after the close of the war and money paid to these men to make good at least part of the loss occasioned by reason of the great depreciation of the continental money during the war.

Baltzer Meese testified that he enlisted in the Second Regiment of Pennsylvania Continental Line, Commanded by Col. Walter Stewart, 1776, and was discharged in 1781. Has a family. See Page 582, Vol. 4, fifth series of Pennsylvania Archives. Affidavit also on file in the Court House at Somerset, Pennsylvania and reads further that his company was commanded by Captain John Stoy. He held United States pension certificate #8458. After his death there was an effort made, and we think a successful one, to have the pension continued to his Widow.

Touching on this, there is an affidavit of Jonathan Knepper on file in the Court House of Somerset, Pennsylvania setting forth that he, Knepper, knew Baltzer Meese and that he was present at his funeral.

We are citing our authority for every statement made concerning the Revolutionary War Service of Baltzer Meese, and are showing that he is the Baltzer Meese that lived in Somerset County, because the records say the places that he lived in this County. We also find the name on the Roll of Captain Patrick Anderson's Company of Pennsylvania Regiment of Foote the time covered by this Roll being from March 1, 1777 to May 1st 1777. Captain Anderson evidently having become the successor of Captain Lewis Farmer who was promoted to Major, and later to Lieut. Col. The authority of this statement is to be found on page 261, Vol. 1st, Pennsylvania in the Revolution. (Published by State of Pennsylvania) his name is also found on a general roll of the Regiment. Captain Lewis Farmer was a citizen of Philadelphia and this makes us think that Meese may have come from that vicinity also; although Lancaster County is not so far away that he could have come from there, from these printed records it is quite plain that men were frequently transferred from on e Regiment to another during the process of the war.

Baltzer Meese died May 15th, 1838. He had a son George living in Somerset Township, and probably died there, as Baltzer Meese and wife are both buried in New Centerville Cemetery, Milford Township, Somerset County, Pennsylvania. He also had a son and daughter living in Brothersvalley Township.

The "Archives" pension records show some discrepancies in giving his age, one says that in 1819 he was 74 years of age, another place his age at 74 in 1835 and this last one probably the correct one, but it would also seem to indicated that he could hardly have been over seventeen years of age when he begun his five years of service in the Revolutionary War.

According to the petition for a writ in the estate of Baltzer Meese as it is on file, his children were, John, George, Christian, Daniel, Sarah who was married to a man named Christian Forney, and who died before her father; and Margaret Meese who was first married to John Keagay or Salisbury; and second to David Steel, also of Salisbury, had several children by the first marriage, and one son Daniel by the second marriage.

About 1840 they all went to Ohio, one of the first sons was named Anthony who about the time of the Civil War, came back to Salisbury and remained there for a year or two. It is the writers' impression that somewhere he had among his papers some correspondence with a grandson of Margaret Meese, who lived at Baltic, Ohio. Daniel Steel, the only son of the Steel's marriage was killed in some accident when about 19 years old, this was about 1854.

John Meese, son of Baltzer we got to know about 1864, he was then quite an aged man, and the writer thinks he had been living somewhere in Fayette County Pennsylvania and had returned to Elk Lick Township where he had two daughters living, one of these was the wife of Peter L. Miller, and they lived about one mile south of Salisbury on the road to Maryland, and another daughter was the wife of Henry Glodfelty living on a farm near by. Mr. & Mrs. Glodfelty had no children, but in the Miller family, there was one son Francis who, had gone to war in 1864 and died while in the service, also a number of daughters, one of whom was the wife of James Maust, who became the owner of the Henry Glodfelty farm after the death of the old people. While Mr. Maust has since sold the farm, we think he still lives in Elk Lick. Of the other Miller girls, we cannot say anything.

John Meese had a son named Soloman, who eventually went back to Fayette County, whether there were still more in the family, the writer does not know.

Christian Meese, son of Baltzer, the writer knew quite well, like his father, he was a miller, his wife was a daughter of Adam Fodery, their sons were Baltzer C., Daniel C., (both millers) John C., Samuel Ca., (blacksmith) and Gillian C. (also a miller) besides two other sons, Christian and William.

Baltzer C. Meese, lived near Accident Garrett County, Maryland, he stood well in the community, he was a Justice of the Peace for quite a while, and died nearly fifty years ago. We think he left a family some of whom may still be found about Accident.

Daniel C. Meese, another son of Christian, operated the Engle Mill in Elk Lick for many years. His wife Susan Engle, both long since deceased.

They had a son John D. Meese, and a daughter Sadie. John D. was finely educated and died some years ago in California, Pennsylvania, where he had been connected with the State Normal School. His wife was Lillian Dom, and they had a family.

George Meese and his wife reared to maturity a family of ten children; namely Elijah, John, Nancy, Margaret, George D., Alexander O., Kesiah, Adeline, Charles O. and Louisa. Of the sons Elijah, John and Alexander went to Ohio. (John probably locating in Tuscarora County) Alexander was in the Civil War and died in the Service.

Of the daughters, Nancy was the wife of Samuel Huston, their family was William, Mary (Connelly) Emma (Kantner) Louisa (Cunningham) Lydia (Sanner) and Rose (Koonts & Zorn) Adeline Meese was the wife of Philip Smith. About the other daughters or George Meese, the writer know nothing.

Daniel Meese, son of Baltzer, the writer knows nothing; but there still remains this to be said, there lived in Greenville Township, a George Meese whom the writer saw once about 1859, then a man well on toward middle age. Whose son he was, the writer does not know except, that he must have been a grandson of Baltzer Meese.

To someone into whose hands this paper may in the future fall, it might be interesting at least to know the names of the other Meese's who were mostly contemporaneous of Baltzer Meese.

First Settlements in the County

The first deed recorded in Brothers Valley was dated 1784. However, there had been settlers in the Brothers Valley area as early as 1769. In 1769, Captain John STEELE was sent to warn settlers in the Brothers Valley area that they must leave Indian Lands. The next year, in 1770, the Rev. George Adam MARTIN, a pastor of the German Baptist Church, recorded that he had a congregation of 18 members in Brothers Valley. And, in 1771, Harmon Husband, arrived to find Philip WAGERLINE, Henry RHOADS Sr., and his sons, and Jacob NEWMAYER living in the area.

These settlers finally decided to form the first town, Berlin, in 1778. They gathered at Pine Hill and planned out the town. However, after much festivities, one of the young men was accidentally killed during a horse race. The town's formation was put off - until Jacob Keffer decided to try to organize a town later.

Jersey Settlement

The Jersey Settlement in Turkeyfoot Twp., was established in 1770. Many of the settlers were from New Jersey and the town was named after them. Drakestown, named after Oliver DRAKE, built the communities first grist mill. David KING followed the Laurel Hill Creek north to the community and founded another grist mill called Kings Mill.

The Jersey Baptist Church, said to be the first church west of the Alleghenies, was built in 1775 by John CORBLEY, a well known Baptist leader, and Issac SUTTON.

Meyersdale, Summit Twp.

The Meyersdale area of Summit Township was first settled by Jacob Castleman, a hunter, who built a cabin along the Little Youghiogheny river. Castleman disappear from the area and Amish-Mennonites and Dunkards arrived shortly after the Treaty of Stanwix in 1768. SAYLOR, BERKEY, KNAIGHEY, BUECHLEY, OLINGER, BURGER, MILLER, FAHRNEY, and BURNTRAGER were some of the earliest recorded names.

Elk Lick Twp.

Peter LIVINGOOD, an Amish preacher, arrived in West Salisbury in 1772.

First Settlers in the County

Somerset's first permanent settler was a German, Philip WAGERLINE, who lived near present day Berlin, in Brothers Valley Township. Wagerline arrived in Somerset (then Bedford County) sometime before 1771 when Herman HUSBAND visited his cabin during the summer of 1771. Wagerline was a farmer and was plowing the rich farm lands when Husband first arrived.

Husand, most notable of the early settlers to Somerset County, was heading for a friend's hunting cabin in the nearby mountains. Issac Cox, a former neighbor of Husband's kept a small hunting cabin in Western Pennsylvania and was living there at the time of Husband's visit.

Harmon Husband, a native of Maryland, was living in Orange County, North Carolina at this time. Shortly after the repeal of the Stamp Act, Husband and others from patriotic Orange County formed a small group called the "Regulators". The Regulators banded together to propose opposition to the growing injustice of the courts in Hillsborough, Orange County, North Carolina. Husband was a devout Quaker and was against violence of any kind. However, the Regulators were more prone to violent acts against the governing justice system and rioted in the city streets.

Husband, was a well known legislator in Orange County, and tried without success to change the law by peaceable means. However, Husband, was arrested for protesting unjust collection of taxes and later was declared by "ex post facto" an instigator in the Hillborough riots.

The Governor, wanting to try Husband for treason, in the hopes of squelching more riots, jerry-rig a jury

and pronouced Husband guilty. The growing tensions between the Governor's forces and the militant Regulators erupted in the Battle of Almance. The Regulator's were severally defeated and the leaders of the rebellion were executed. Husband was forced to flee pending immediate execution. He left North Carolina and returned to his homeland of Maryland. However, word had been spread about him and the Governor of Maryland gave stern warning to anyone in Maryland and Virginia who had thoughts of harboring any of the fugitives of the Battle of Almance.

Harmon Husband, stayed in Somerset County (then Bedford) and built a cabin six miles from Wagerlines. Husband, fearing the use of his real name, went by the pseudonym of "Tuscape Death" (To Escape Death). Wagerline and Cox, however, preferred to call him the "Old Quaker".

Issac Cox later sold his land to Harmon Husband (known later as BARRON Farm) and moved west. Husband acquired several thousand acres of land, most of present day Somerset. Husband, later became one of the first Assemblymen to the Pennsylvania Legislature from Bedford County following it's organization after the Declaration of Independence.

In 1776 he plotted most of the town of Somerset. In 1790, he presented the petition to the legislature requesting the formation of Somerset County. He died in 1795, following an unjust imprisonment in Philadelphia, only a few months short of seeing Somerset chosen as county seat.
